

Villa Park High School
Wrestling Boosters Meeting
July 24, 2007

President Andree Candelaria called the meeting to order at 6:45 pm
In attendance were Andree Candelaria, Coach Cross, Bob Peterson, and Kristine Peterson

President's Report

It was announced that Lesley Zorola had handed in her resignation and it had been accepted by Andree Candelaria, leaving the Secretary's position vacant.

The minutes from the June 12, 2007 meeting were read and approved.

Andree Candelaria gave Bob Peterson all of the past Treasurer's files, checks to be deposited, donated items and money for the Spartan Classic Auction. She also said that she had balanced the account prior to handing over all of the information and it balanced to the penny. Current balance as of July 24, 2007 is \$5607.67.

Deposits to be made \$170.00

Expenditures approved-

\$3000.00 to OUSD for summer camp (25 wrestlers @ \$120 each)

Up to \$50.00 for deposit and paid stamp

\$80 to be set aside to cover registration flyers

\$375.00 paid to Coach Cross for T-shirts (receipt to be provided by next meeting)

ASB Account – All checks for tournaments, fundraisers and on campus fundraisers must go through this account.

Coach's Report

Ring worm was discussed and possible ways to prevent it.

Certificate for Spartan Classic Auction given to Bob Peterson for fishing trip.

January 12, 2007 Tournament – Coach Cross has received 3-4 verbal confirmations and hopes for a maximum of 12 teams. It is better to start small and grow. It was decided that we will have Jamba Juice come to the tournament as a fundraiser at Noon.

Wrestling makes no money on admission at dual meets, but we do earn the entry money from our tournament as well as snack bar money.

Summer camp update- 20-30 wrestlers showed up consistently when practices held at Villa Park. Travel days started falling off. The coach was happy with the turn out. We had 18 wrestlers compete in the tournaments held on Friday 7/20 and Saturday 7/21 and they did pretty well. Coach Cross has great hope for the future. Not all participants were

charged; younger siblings and football players who only attended occasionally were not asked to pay.

Cell phone fundraiser has raised \$1193.00 so far. Flyers went out in all registration packets and the coach will put a drop box outside of the wrestling room for drop off. He will then check it and collect all contents each day.

E-Scrip is up and running. Coach Cross gave Bob Peterson all of the information and it was discussed how we can promote it. It is currently listed on our website.

Spartan Classic

All information from the past meetings was handed over to Bob and Kristine Peterson. It was brought up again that we must have (4) volunteers to work that day and Andree said her son and another wrestler would work the AM shift. Therefore, we only need (2) more volunteers to work the PM shifts.

Bob Peterson also let everyone know that he had received a donation for (4) people to go out on a harbor cruise with the OC Sheriff's Dept. Harbor Patrol.

New Business

Bob Peterson brought up the Ice Cream Sales at the OC Fair Grounds (Swap meet) and said the application needs to be submitted. He explained that if approved, we would be scheduled the 1st quarter of 2008 and typical earnings are between \$1000-1500. It was decided that March would be the best month, because wrestling would be over.

We still need a Snack Bar Chair, Secretary, Fundraising Chair and Photographer. A list of possible candidates names were given to Coach Cross for him to contact.

There was discussion of buying gear for the Varsity team, such as sweats, to make them stand out. We also talked about buying bags for the entire team. The coach said he would research the costs and bring them with him to the next meeting.

Coach Cross mentioned that he doesn't have enough of any one singlet to make up an entire team, but he does have approximate 40 new all black singlets that he would like to have silk screened, so everyone looks the same.

The topic of doing another Program this year was discussed and it was decided to shelf this topic until a later meeting.

Meeting adjourned at 8:36 PM.
