

**Villa Park High School
Wrestling Boosters Meeting
April 08, 2008**

President Andree Candelaria called the meeting to order at 6:55 pm

In attendance: Andree Candelaria, Coach Cross, Bob Peterson, Richard Ikeda, Jim Peterson, Claudia Peterson, Marilyn Ikeda, and Harvey Lotstein (Accountant)

Secretary's Report

The minutes from the March 11, 2008 meeting were read. Bob Peterson motions to approve minutes. Richard Ikeda seconds the motion and minutes are approved. Minutes are posted on website.

Treasurer's Report

Bob Peterson presents summary of pending expenditures, which were brought before the Board for approval:

Pull Up Bar installation hardware. (\$28.46) – President Andree motions to approve expense. Treasurer Bob seconds motion. Board votes – Motion carried by unanimous vote.

GKL – Certified Copies “Articles of Incorporation”. (\$44.00) - President Andree motions to approve expense. Treasurer Bob seconds motion. Board votes – Motion carried by unanimous vote.

Tax Filing to be completed by Harvey Lotstein (CPA) Pro Bono.

Current Bank Statement balance of \$8,869.57. Treasurer has \$90.15 deposits from the website ads through “Commission Junction”.

Budget

Coach requests budget for 3 sets of “Dip Bars” @ \$65-\$70 a set not to exceed \$300 including installation hardware. - President Andree motions to approve expense. Treasurer Bob seconds motion. Board votes – Motion carried by unanimous vote.

Coach requests budget for 20 jump ropes @ cost not to exceed \$400. - President Andree motions to approve expense. Treasurer Bob seconds motion. Board votes – Motion carried by unanimous vote.

Coach suggests Boosters subsidize summer camp fees (\$100 toward an approved Camp) of those wrestlers that attend 20 practices and 5 tournaments. (Anticipates 10-15 eligible wrestlers at the end of the freestyle program.) - President Andree motions to approve expense. Treasurer Bob seconds motion. Board votes – Motion carried by unanimous vote.

President Andree motions to approve assistant coaches’ gifts not to exceed \$50 each (Gift Certificates to Restaurants). Richard seconds motion. Board votes – Motion carried by unanimous vote.

Coaching Update

Coach proposes wrestling camp in Pomona (July 7th -11th). \$300 for 5 days for daily camp commuters. (Coach cannot attend as it is during summer school classes.)

Coach proposes a second wrestling camp in Brea (July 23 -?) \$200 for 5 days. (Coach can attend and transport 4-5 wrestlers as it is after summer school classes)

Freestyle practice continues w/Saturday tournaments.

Athletic Night/Open House to be held on April 30, 2008. Physical Forms are available on website for wrestlers to fill out and submit.

Fundraising

Cell phone fundraiser is ongoing throughout school year. Coach Cross has a drop box outside of the wrestling room for drop off. He checks it and collects all contents each day.

E-Scrip is up and running.

Coach suggests to board via email on 3/24/08 to convert deposits from website adds to direct deposit.

Membership

Present the Booster Board at the Banquet and recruit members for open slots. Anyone interested in current position or fulfilling open position may sign up for position on next years board.

New Business

End of Season Banquet to be held at Foxfire on April 20th from 4-7pm. Menu consists of Fettuccini Alfredo, Chicken, and Ribs. RSVP by 4/16 with Wrestlers and guest. Anticipate 80-100 in attendance. Banquet is being hosted and sponsored with all wrestlers are covered compliments of the Adams Family. The cost of the family and guests of wrestlers is a very generously discounted \$15 per person.
