Coaching Update

4 Wrestlers made it to CIF:

Freestyle Wrestling program starts. Tuesday and Thursday (6:30pm – 8:30pm) practices at Canyon will have at least one VP Coach present for our wrestlers and Freestyle Tournaments to be held on Saturdays.

Coach Cross requests \$1200 stipend (\$100 per week for 12 weeks) paid to Coach Cross and distributed to the attending coach.

Coach Cross recommends Wrestling Camp in Reno held in mid July. Wrestlers showing dedication during season and post season will have their camp fees subsidized.

End of Season Banquet was discussed and it was suggested to hold the banquet at Foxfire or Banquet Hall after Masters. Jim Peterson motions for Banquet to be held either April 13th or 20th. Jim Peterson seconds the motion. A vote is held to decide on the Foxfire or the Banquet Hall and Foxfire wins by unanimous vote. Coach Cross emails Contact at Foxfire from meeting. Wrestlers are free all others will be \$12 per person.

Fundraising

Cell phone fundraiser is ongoing throughout school year. Coach Cross has a drop box outside of the wrestling room for drop off. He checks it and collects all contents each day.

E-Scrip is up and running. Coach Cross gave Bob Peterson all of the information and there was discussion on how we can promote it. It is currently listed on our website.

We will not have a new T-Shirt project at this time.

Bob Peterson brought up the Ice Cream Sales at the OC Fair Grounds (Swap meet) and said the application needs to be submitted. He explained that if approved, we would be scheduled the 1st quarter of 2008 and typical earnings are between \$1000-1500. March would be the best month, because wrestling would be over.

There was discussion of buying new singlets for the team or having the plain black singlets embroidered with VP logo.
